No. ECF.200418/I/340735/2023 : The following draft of certain rules further to amend the Settlement Rules, Chapter 1, section 1 of Assam Land and Revenue Regulation, 1886, hereinafter referred to as the principal rules, which the Governor of Assam proposes to make in exercise of the powers conferred by sub-section (1) of section 12 of the Assam Land and Revenue Regulation, 1886, is hereby published, as required under section 157 of the said Act, for the information of all persons likely to be affected thereby and the notice is hereby, given that the said draft rules shall be taken into consideration after the expiry of a period of fifteen (15) days from the date of publication of this notification in the Official Gazette.

Any objections or suggestions, which may be received from any individual with respect to the said draft rules before the expiry of the period specified above shall be considered by the Government of Assam.

Objections or suggestions, if any, may be sent to the Secretary to the Government of Assam, Revenue and Disaster Management Department, Janata Bhawan, Dispur, Guwahati-6.
