## Terms and Condition:-

- 1. The intending tenderer may inspect the scrap items during office hours any working day from 11.00 A.M. to 4.00 P.M. before the bid submission deadline.
- 2. Bids without security deposit will not be consider and shall be automatically rejected.
- Security deposit of unsuccessful bidders will be returned, and in case of successful bidder, the security deposit will be refunded after lifting of the scrap items.
- 4. Right to reject Auction:- Auction inviting authority reserves the right to accept or reject the whole auction at any point of time without assigning any reason thereof.
