# ORDERS BY THE GOVERNOR NOTIFICATION

**SUBJECT:** Declaration of services under Revenue & D.M. Department as per provision of the Section 4 of the Assam Right to Public Services Act, 2012.

With a view to provide the delivery of Public Service to the eligible citizens within stipulated time limit, the following service of the Revenue & D.M. Department has been identified as Notified under Section 4 of the Assam Right to Public Services Act, 2012.

### Service Name: Reclassification of Land land less than 1 bigha

If the usage of land is changed, the class of land also requires to be changed from the existing to a new land class. This notification is for reclassification of agricultural/non-agricultural land to other class if the land area is below one bigha.

#### **Eligibility Criteria:**

Only patta holders can apply for the Reclassification of Land. Applicants can be multiple co-pattadars of the same patta. In one application, applicants can apply for a single patta only.

#### **Designated Public Servant (DPS):**

Additional Deputy Commissioner (Revenue).

#### **Procedural Steps:**

The Applicant has to apply in Standard Application Format along with required documents before the O/o the Circle Officer. On Receipt of the Application, The Lot Mandal physically verifies the land and write a Report for the Reclassification of the scheduled Land. Circle Officer verifies the Report and forwards to Additional Deputy Commissioner/Deputy Commissioner. After ADC/DC approves the application, gives the final order and passes the order for chitha correction. Everything will remain same except the land class code will change.
